

## Terms & Conditions

These Terms and Conditions are the Raffle Rules. By entering the raffle, entrants agree to be bound by these rules.

Thank you for supporting St Oswald's Hospice Big Car Raffle. The closing date to enter online is Monday 18th November 2024 and the draw will take place on Saturday 23rd November 2024. Any money received after the closing date will be treated as a donation.

Cheques to be made payable to St Oswald's Hospice Ltd. Please be aware that credit card payments will not be accepted online or over the phone. No tickets may be sold to persons aged under 16 and the maximum number of tickets which can be purchased is 200 per person.

If any ticket/s are unknowingly sold to a person who is under the age of 16, they will be exempt from the raffle, they will forfeit their prize and their entry money will be returned to them.

All tickets shall be priced at £1. All raffle entry sales are final and no refunds shall be made at any time. All entrants acknowledge that their payment of £1 per ticket to enter the Big Car Raffle does not guarantee that they will win any prize. Full payment for each ticket must be received either in the form of cash or cleared funds before the ticket can be entered into the draw. Only tickets for which full payment has been received either in the form of cash or cleared funds are eligible to win the prize.

Winners will be notified by telephone, email or post no later than two weeks after the draw date. All entrants are solely responsible for providing St Oswald's Hospice Promotions Ltd with their accurate and up-to-date contact details and St Oswald's Hospice Promotions Ltd will be in no way liable for any failure or inability to contact any entrant due to any errors, omissions or inaccuracies in the contact details that the entrant has provided. In the event that an entrant changes their contact details, they will be solely responsible for advising St Oswald's Hospice Promotions Ltd of the change.

Winners will be selected by St Oswald's Hospice Promotions Ltd drawn from a traditional mean of all physical tickets in a container. The results of the draw are final. St Oswald's Hospice Promotions Ltd reserves the right to disqualify any entrant if it has reasonable grounds to believe the entrant has breached any of these rules.

**Proceeds and prizes:** Based on a previous raffle raised £36,091 in ticket sales. 89% of this went towards the work of the Hospice, 0% on prizes with the prizes being donated free of charge and 11% on production expenses (e.g. tickets, promotion).

With 36,091 tickets sold and 1 prize to be won, each ticket had a 0.003% chance of winning a prize. Your chances of winning a prize in the Big Car Raffle will depend on the number of entries in the draw.

In the Big Car Raffle one prize is available which has been donated by Bristol Street Motors, part of Vertu Motors PLC. The company donated the brand new car and put St Oswald's Hospice as the first original owner.
